VINCENT LLESHAJ – 130 WILDEY STREET

The Board reviewed plans for the installation of a wall sign.

Acting Chairman Mignogna questioned whether anyone wished to address the Board on this matter.

No one appeared.

Mr. Mignogna moved, seconded by Mrs. Bryan-Morgan and unanimously carried to approve the installation of a wall sign at 130 Wildey Street as shown on the plans received by the Building Department dated May 27, 2021 and May 28, 2021 subject to:

1. The location of the sign to be moved about 1' to the right and centered over the front door.

TEDD TRADING LLC – 27 NORTH BROADWAY

Ms. Christine Broda, architect, reviewed with the Board plans for new signage and awning for new restaurant in the Broadway Sign District.

Acting Chairman Mignogna questioned whether anyone wished to address the Board on this matter.

Mrs. Kozlowski moved, seconded by Ms. Kopelman and unanimously carried to approve and issue a sign variance for new signage and awning including a new lift at 27 North Broadway as shown on the plans received by the Building Department dated September 3, 2021, October 29, 2021 and November 2, 2021.

ASHES INTO GLASS – 104 SOUTH BROADWAY

The board reviewed plans for a new sign in the Broadway Sign District.

Mrs. Bryan-Morgan moved, seconded by Mrs. Kozlowski and unanimously carried to approve a new sign at 104 South Broadway as shown on the plans received by the Building Department dated October 19, 2021.
