Re: Water Rates and new Water Meter Rental Fee to help fund water capital improvements

Dear Tarrytown Water Customers:

The Village of Tarrytown's Water Meter Replacement Project is nearing completion and we are pleased to report that we have replaced water meters for 2,268 customers. With more accurate, real-time reporting the system is now better able to detect leaks and other issues.

With the completion of the water meter replacement project, the Village is instituting a new water meter rental fee. The revenues from this fee on your bill will go towards reducing our reliance on borrowing for future water projects such as the one we have just undertaken. In addition to replacing future water meters, impending capital projects include continuing replacement of aging water mains, renovations for the pump station, and other infrastructure projects critical to a safe and healthy water system. The water meter rents will apply to each customer – resident or business owner – based on the size of the water meter and the water service line that serves your building. The vast majority of residential customers have 5/8" or 3/4" meters. The full chart for the quarterly and monthly meter charges is listed below.

Your bill this month will also reflect a 7.8% increase in water rates. This increase reflects the 7.8% increase in supply charges imposed by the New York City Department of Environmental Protection (NYCDEP) since 2021 when the Village last increased water rates.
