#### MOMENT OF SILENCE – GERALD BARBELET

Mayor Fixell stated that Jerry Barbelet, a lifelong resident of Tarrytown, passed away on June 12<sup>th</sup>. He had a remarkable 37-year career as Treasurer with the Village of Tarrytown. He also held positions as Acting and Deputy Administrator and Deputy Clerk. He had been a member of the Tarrytown Volunteer Fire Department for over 50 years. He loved the Village of Tarrytown and we will miss him. On behalf of the Board of Trustees, we send our sincere sympathy to Jerry's wife Maureen and his sons, Kevin, John and Dennis and the entire Barbelet family.

### PRESENTATION AND SWEARING IN OF POLICE LIEUTENANT BADGE TO LIEUTENANT DALY

Mayor Fixell announced the promotion of John Daly to the position of Lieutenant and congratulated him on his new position with the Police Department. Mayor Fixell along with former Mayor Eileen Pilla presented him with his Tarrytown Police Lieutenant badge. Ms. Pilla noted that it was a pleasure pinning John Daly's police badge on him when he was hired as a police officer in the Tarrytown Police Department in 1993. However, it is a bigger pleasure for her to stand here tonight to pin on his Lieutenant badge. Ms. Pilla noted, as she looked around the room, there are many bright police personnel who had joined the police force over the years. Tarrytown is moving forward and is a wonderful place work.

Lieutenant Daly thanked his family, friends and co-workers in the police department. He also thanked the Mayor, Board of Trustees, Police Chief Scott Brown and two past co-workers, Bob Kearns and Dennis DeCuffa. He thanked all the residents of Tarrytown for the opportunity to serve them. He thanked his nieces, Meghan and Kathleen and especially his mom who is always there for him every step of the way.

### PRESENTATION AND SWEARING IN OF POLICE SERGEANT BADGE TO SERGEANT JONES

Mayor Fixell announced the promotion of Andrew Jones to the position of Sergeant and congratulated him on his new position with the Police Department. Mayor Fixell along with Police Sergeant Jone's wife presented him with his official Tarrytown Police Sergeant badge.

#### PROCLAMATION – THE RIVER TOWNS LIONS CLUB

Mayor Fixell read the following proclamation:

WHEREAS, The River Towns Lions Club was created to promote the principles of good government, to foster the spirit of understanding among people and to take an active interest in the civic, cultural, social and moral welfare of the community; and

#### **REPORTS**

#### ADMINISTRATORS REPORT

Administrator Blau reported on an update on the new Recreation Building and swimming pool. Administrator Blau was provided a letter from the developer notifying him about the dedication of the Recreation Building, but it did not mention when the dedication would take place. Mr. Blau requested the developer to resubmit a new letter with the date that the Recreation Building will be dedicated over to the Village. On Monday, June 27<sup>th</sup>, the Recreation Department will begin to move into the new recreation building. They are setting up the office area with telephones and computers. However, without the letter in place from the developer, the final move cannot take place. At this time, we do not have a date for the pool opening. Once the construction is complete, the health department must sign off before it can be dedicated to the Village. When the Village receives a realistic date of completion from the developer, the Village will commence the process to seek out life guards.

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute an addendum agreement with Complus Data Innovations, Inc., Tarrytown, New York, for the assignment of certain unpaid parking tickets to a secondary collection process with a Complus partner company, Capital Recovery Systems, Inc.

#### <u>AGREEMENT WITH WESTCHESTER COUNTY – STOP DWI</u> PATROL/DATAMASTER PROJECT

Trustee McGovern moved, seconded by Trustee McGee, and unanimously carried, that the following resolution be approved: Approved: 6-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby authorize and direct the Village Administrator to execute a contract with Westchester County for reimbursement in the maximum amount of \$8,400 per year for costs associated with the Stop-DWI Patrol/Datamaster Project. This agreement shall commence on January 1, 2016 and continue through December 31, 2020.

## APPROVAL OF TENTATIVE AGREEMENT BETWEEN THE CIVIL SERVICE EMPLOYEES ASSOCIATION AND THE VILLAGE OF TARRYTOWN

Trustee Butler moved, seconded by Trustee McGovern, and unanimously carried, that the following resolution be approved: Approved: 6-0

WHEREAS, the negotiating committees for the Village and the Civil Service Employees Association, Village of Tarrytown Unit #8212, Westchester County Local 860 ("CSEA") executed a Tentative Agreement on May 2, 2016 for a successor collective bargaining agreement to commence on June 1, 2016; and

WHEREAS, it was fully understood by the parties that the Tentative Agreement required ratification by the membership of the CSEA and approval by the Board of Trustees; and

WHEREAS, the Village was notified that the membership of the CSEA voted to ratify the Tentative Agreement on June 1, 2016; and

WHEREAS, the authorized salary increases associated with the four-year agreement are: June 1, 2016 through May 31, 2017 – 2.0%: June 1, 2017 through May 31, 2018 – 2%; June 1, 2018 through May 31, 2019 – 2%; June 1, 2019 through May 31, 2020 – 2.0%.

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby approve the terms of the Tentative Agreement dated May 2, 2016 for a successor collective bargaining agreement to commence on June 1, 2016 through May 31, 2020.

BE IT FURTHER RESOLVED that the Board of Trustees does hereby authorize and direct the Village Administrator to execute the successor collective bargaining agreement with the CSEA.
